## Statement of the Spokesperson of The Ministry of Foreign Affairs and International Cooperation

The Ministry of Foreign Affairs and International Cooperation, in its most unequivocal terms, rejects the assertion made by several foreign media and institutions that led the public to believe that Cambodia may have allowed passengers carrier of the virus to leave the Westerdam cruise ship which increased global coronavirus spread. Such hasty, unsubstantiated, unprofessional and accusatory driven articles and statements have spurred unnecessary fears and confusion among the public regarding the spread of the virus COVID-19, caused prejudicial discrimination on the passengers of the Westerdam Cruise ship, and aimed ill-intently to devalue Cambodian humanitarian gesture and health competence.

Acting with the utmost compliance with the international health regulations and in full concertation with health authorities of global stature like the World Health Organization, the Institut Pasteur du Cambodge (IPC) and the US Center for Disease Control and Prevention (CDC), the Cambodian Ministry of Health have tested and cleared all 2,257 passengers and crew members of the Westerdam Cruise ship of the COVID-19. Concerning the 83-year-old American woman who initially was supposedly tested positive for the virus in Malaysia, the US Centre for Disease Control and Prevention (CDC) as a globally recognized health authority has rejected the result of these tests and has affirmed through its spokesperson that: "I have confirmed that all the passengers were tested, and they have come negative for coronavirus, including the person who initially tested positive". Moreover, in line with the CDC findings, the
